Executive Director's Report - Patti

Kellie Mott-LeCroix - will work with Friends on water development inventory wants to attend training, week of 10/17 is open

Grants, Agreements and Supplemental Project Agreements - Brooke Wheelock Grants, agreements and SPAs have become centralized at the regional level and how they are administered has changed significantly from what Friends was told to do previously.

Brooke is not sure that a Challenge Cost Share is the appropriate tool for Friends. It has start and end, for example in five years)

SPAs are not needed yearly! SPAs are only necessary if the Forest needs to be involved, or if Friends is bringing in third party contractors. SPAs are unusual. Brooke will let Friends know if we will need a SPA.

Friends does need to provide the following documents to the FS yearly:

Program of Work (POW) Financial plan

FLT meets quarterly (or maybe bimonthly) and will need to approve the Program of Work.

Volunteer coverage by FS Workers Compensation

What if Friends calls Dispatch and notifies staff about going out and doesn't get a response, can we still go? (and be covered). Brooke will check with Clarence and let Friends know.

Staff would have to respond if Friends makes any change to the plan.

Under a *Volunteer Agreement* volunteers only qualify for FS Workers Compensation if FS person there, signs people in, provides tools, and does training. if use 301 form then they are covered

With Challenge Cost Share, FS partners are expected to provide own insurance for volunteers

Currently Friends is under 301, but that needs to change, FS presence is usually required for 301s
